EMPANNELMENT OF TISSUE CULTURE BANANA PLANTLET VARIETY BANTAL & GRAND NAINE PRODUCER

The Director of Horticulture & Secretary, OHDS invites Expression of Interest in sealed cover from Public Sector Undertakings/ Private Entrepreneurs/Agencies engaged in producing Tissue Culture Banana Plantlet, intending to supply the same to the farmers of Odisha under Govt. programme for the year 2018-19. The sealed Expression of Interest should be submitted to this Directorate on or before 03.04.2018 by 5.00P.M. by Registered/ Speed Post (P&T Deptt.) only. The Technical Bid will be opened on 04.04.2018 at 11.30 A.M. and the Financial Bid will be opened on 05.04.2018 at 11.30 A.M. in the Conference Hall of this Directorate. The sealed envelope should be super scribed with "EOI for Empanelment of Producer for supply of Plantlet of T.C Banana for 2018-19" The detail including terms and conditions of the Expression of Interest is available in the website.

TERMS OF REFERENCE

- 1. The last date for submission of the Expression of Interest (EOI) is 3.04.2018 at 5.00 P.M and the technical bid will be opened on 4.04.2018 at 11.30 AM. In the Conference Hall of the Director of Horticulture. The financial bid will be opened on 05.04.2018 at 11.30 AM at the same venue.
- The EOI will be valid up to 31st March, 2019.
- The bidder or authorized representative shall be present at the time of opening of the EOI.
- 4. In case of absence of the bidders or their representative the Committee has the right to open the EOI.
- 5. The EOI is meant for empanelment of T.C plantlet producers of variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani.
- 6. Only the Producer of plantlet of T.C. Banana variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani shall take part in the process.
- The Producer has to furnish valid copy of accreditation with DBT Certificate, Virus Indexing Certificate, Genetic fidelity Certificate, production capacity, GST Certificate, PAN No along with Technical Bid.
- The Financial offer should be FOR farmers point.
- 9. The rate offered and approved by the State Level Seed Pricing Committee shall be valid till 31.03.19.
- 10. The Producer/Supplier has its own responsibility to sale the plantlets to farmer at approved rate. The supplier has also to furnish valid receipt to farmer in support of sale.
- 11. In case where the full cost of planting material will be borne by the concern schemes and the procurement shall be made by the Govt. the planting material should be procured from the L1 supplier out of the empanelled suppliers. Provided if there is sufficient reason, the district level committee headed by Collector will be competent to finalize the procurement from among the empanelled supplier at the approved price and not opt for L1 supplier. However, necessary justification should be recorded in the minutes of the committee.
- 12. Quality of the plantlet is the sole responsibility of the producer.
- 13. Any dispute arising due to plantlet quality in the field will be verified through scientist from OUAT/ KVK/ CTCRI/ CHES/RRTTS Dept. officials or Team as constituted by Director of Horticulture, Odisha.

- 14. There should not be any precondition of advance payment or time limit, what so ever. Any bid submitted will be taken as absolute without any precondition.
- 15. The plantlet of T.C. Banana variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani will be sold to the farmers by the bidder. Government is proposing to provide subsidy to the farmers who cultivate T.C. Banana variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani. procuring from the empanelled suppliers on crop coverage basis.
- 16. The producer should have / have to establish hardening centre in Odisha which should be verified from time to time by the DDH / ADH and the Scientist from the KVK/RRTTS/OUAT if required.
- 17. Supplier will be empanelled for sale throughout the State.
- 18. The source verification i.e. plantlet of T.C. Banana variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani. production requirement, mother plant, production capacity, technical manpower etc. shall be verified by the expert team constituted by Director of Horticulture.
 - 19. Those who are importing the culture from outside India, they should maintain a trial plot of at least 0.5 ac. showing the performance of mother culture which will be verified during source verification by the expert team.
- 20. The plantlet of T.C. Banana variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani. will also be verified after arrival at Sub-Divisional level before delivery to the farmers.
- 21. The cost of verification at all level and cost of other testing if required will be borne by the supplying agency
- 22. The Director of Horticulture & Secretary, OHDS reserves the right to reject the bid quoted by any organization / agency, if not satisfied with concerned organization / agency's credibility and past experience. Further the Director of Horticulture & Secretary, OHDS also reserves the right to accept/ reject/ modify any or all clauses of EOI without assigning any reason thereof.
- 23. EMD of Rs. 5.00 lakh (Rupees five lakh) per producer should be attached with EOI in shape of Bank Draft payable to Director of Horticulture and Secretary, OHDS, Bhubaneswar in any nationalized bank situated at Bhubaneswar along with technical bid. The said EMD shall be kept till 31.03.2020 or confirmation by the DDH/ ADH regarding quality of Plantlet.

24. The bidder shall fill up the Financial Bid as well as Technical bid and submit in separate sealed cover along with necessary documents. The Technical Bid & Financial Bid should be put in separate envelope and super scribed as Technical Bid / Financial Bid as the case may be. Both the bids should also be put inside another sealed envelope and super scribed with "EOI for empanelment of producers for supply of plantlet of T.C. Banana variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani. for 2018-19". The same should be sent through P & T Department by Registered Post / Speed Post only to the Office of the Director of Horticulture, Odisha, Bhubaneswar without any precondition and should have to reach before the date & time fixed for this purpose.

25. The technical bids will be evaluated by a committee constituted for the purpose and the findings of the committee will be final and binding. The same cannot be challenged at any forum thereafter. Intending bidder will have to submit undertaking in

this regard.

26. No communication shall be entertained over Telephone, FAX, E-

mail or in person.

27. The supplier shall abide by the stipulated date for sale of plantlet of T.C. Banana variety Bantal, Grand Naine, Patakapura, Champa, and Amrutpani. to the farmers fixed by the ADH / DDH / Director of Horticulture & Secretary, OHDS.

- 28. An undertaking in a Rs.10/- Non-Judicial stamp paper stating the following has to be attached with the technical bid:
 - a. The decision of the evaluation committee will be final and binding.
 - b. Company will be liable for quality of the plantlet.
 - c. If the plantlet quality is found to be defective or poor, the company will refund the cost of plantlet and pay compensation as decided by the technical committee constituted for this purpose.
 - d. I agree to supply plantlets to the famers of the State at the offered price irrespective of the places.
- 29. One producer has entailed to submit one bid only.
- 30. The interested agencies may download the EOI documents including format of Technical Bid and Financial Bid from the department. website www.orihort.in and also from www.orissa.gov.in.
- 31. Any legal dispute shall be finalized in Bhubaneswar Jurisdiction only.
- 32. Any complicacy arises above these points of the ToR will be settled mutually.
