Expression of interest

The advertisement issued earlier vide this office It. no. NHM (H2)22/16 2/2948 Dt. 13.03.2018 is hereby cancelled.

Fresh applications are invited from the eligible Public Sector Undertaking (Central/State/Cooperatives) engaged in producing Ginger & Turmeric Variety mentioned in the Terms & Conditions intending to supply the same to the farmers of Odisha for the year 2018-19. The sealed Expression of Interest should be submitted to this Directorate on or before 13.04.2018 by 5.00 P.M. by Registered/Speed post (P & T Deptt.) only. The Technical Bid will be opened on 16.04.2018 at 11.00 A.M. and the Financial Bid will be opened on 16.04.2018 at 3.00 P.M. in the conference hall of this Directorate. The sealed envelope should be super scribed with "EOI for Empanelment of producer for supply of Turmeric & Ginger for 2018-19." The detail including terms and conditions of the Expression of Interest is available in the website.

Terms and Conditions

- 1. The EOI will be valid up to 31st March, 2019.
- 2. The bidder or authorized representative shall be present at the time of opening of the EOI.
- 3. In case of absence of the bidders or their representative the Committee has the right to open the EOI.
- 4. The EOI is meant for empanelment of State Level PSUs, National Level PSUs, Co-operatives producing seeds material by their own or organizing farmers.
- 5. Only State Level PSUs, National Level PSUs, Cooperatives producing seeds material by their own or organizing farmers shall take part in the process.
- 6. The agency who will take part in the empanelment has to submit an undertaking to the effect that the organization is producing seeds material by their own or organizing farmers.
- 7. The financial offer should be FOR at Sub Division level.
- 8. The rate offered and approved by the State Level Seed Pricing Committee shall be valid till 31.03.2019.
- 9. The agency has its own responsibility to sell the seed material to farmer at approved rate. The agency or its authorized agent has also to furnish valid receipt to farmer in support of sale.
- 10. In case where the full cost of seeds material will be borne by the concerned schemes and the procurement shall be made by the Govt. the seeds material should be procured from the L1 agency out of the empanelled suppliers, provided if there is sufficient reason, the District Level Committee headed by Collector will be competent to finalize the procurement from among the empanelled supplier at the approved price and not opt for L1 supplier. However, necessary justification should be recorded in the minutes of the Committee.

- 11. Quality of the seed material is the sole responsibility of the agency.
- 12. Any dispute arising due to quality of the planting material in the field will be verified through scientist from ADR, Similiguda, OUAT/KVK/CTCRI/CHES/RRTTS/Dept. Officials/one officer from OSSOPCA or Team as constituted by Director of Horticulture, Odisha.
- 13. There should not be any precondition of advance payment or time limit, what so ever. Any bid submitted will be taken as absolute without any precondition.
- 14. The Turmeric/Ginger planting material variety Ranga, Rashmi, Lackdong, Surama, Suprava & Suruchi will be sold to the farmers by the bidder. Government is proposing to provide subsidy to the farmers who purchase the same for cultivation from the empanelled agency.
- 15. The agency should have / have to give franchise at least at Sub Division level. The agency has to provide the dealership list / authenticated sale point to the DDH/ADH as well as to this Directorate.
- 16. The agency and its authorized agents selling the planting material should have seed license of the state.
- 17. Agency will be empanelled for sale throughout the state.
- 18. The source verification i.e. Turmeric / Ginger planting material, production requirement, production capacity, technical manpower etc. shall be verified by the expert team constituted by Director of Horticulture.
- 19. The source verification shall be made in the month of March & April.
- 20. The cost of verification at all level and cost of other testing if required will be borne by the supplying agency.
- 21. The Director of Horticulture reserves the right to reject the bid quoted by any organization / agency, if not satisfied with concerned organization / agency's credibility and past experience. Further the

Director of Horticulture also reserves the right to accept / reject / modify any or all clauses of EOI without assigning any reason thereof.

- 22. The bidder shall fill up the Financial Bid as well as Technical Bid and submit in sealed cover along with necessary documents. The Technical Bid & Financial Bid should be put in separate envelope and super scribed as Technical Bid / Financial Bid as the case may be. Both the bids should also be put inside another sealed envelope and super scribed with "EOI for empanelment of agency for supply of Turmeric/Ginger planting material variety for 2018-19". The same should be sent through P & T Department by Registered post / Speed post only to the Office of the Director of Horticulture, Odisha, Bhubaneswar without any precondition and should have to reach before the date and time fixed for this purpose.
- 23. The agency has to submit seed quality, seed license for state, production capacity, GST Certificate, PAN no, an undertaking in a Rs.10 stamp paper, details distribution strategy along with technical bid.
- 24. The technical bids will be evaluated by a committee constituted for the purpose and the findings of the committee will be final and binding. The same cannot be challenged at any forum thereafter. Intending bidder will have to submit undertaking in this regard.
- 25. No communication shall be entertained over Telephone, FAX, E-mail or in person.
- 26. The agency shall abide by the stipulated date for sale of Turmeric / Ginger planting material to the farmers fixed by the DDH/ADH/Director of Horticulture.
- 27. An undertaking in a Rs.10/- Non Judicial stamp paper stating the following has to be attached with the technical bid:
 - a. The decision of the evaluation committee will be final and binding.

- b. The agency shall be liable for substandard germination / poor performance of planting material.
- c. If the Turmeric / Ginger planting material is found to be spurious, the agency will refund the cost of seeds and or pay compensation as decided by the technical committee constituted for this purpose.
- d. I agree to supply Turmeric/Ginger to the farmers of the state at the price fixed by the State Level Seed Pricing Committee or offered price irrespective of the places.
- 28. One agency is entitled to submit one bid only.
- 29. Non refundable Bank Draft of Rs.3,000/- to be drawn in favour of Director of Horticulture & Secretary, OHDS.
- 30. The interested agencies may download the EOI documents including format of Technical Bid and Financial Bid from the department website www.odihort.nic.in and also from www.orissa.gov.in.
- 31. Any legal dispute shall be finalized in Bhubaneswar jurisdiction only.
- 32. Any complicacy arising out of the points of the Terms & Conditions will be settled mutually.
